

BRIDLEVALE HOMEOWNERS' ASSOCIATIONS POOL RECREATION CENTER RULES & REGULATIONS

1. Contracted personnel, such as, access control personnel (Security Company) or pool monitors have authority on any matters pertaining to the entire recreation centers rules & regulations; this includes requests for identification or key verification.
2. A shower should be taken before entering the pool/spa/ wader.
3. All persons must observe posted hours.
4. Guests must be accompanied by a resident at all times when using the pool or spa facilities. Number of guests per unit is not to exceed four (4) at one time. Keys may not be duplicated or loaned to friends.
5. Entrance to the Recreation Center shall be through the gates only. Climbing over the fencing or gates is prohibited. The gates must be closed and locked at all times.
6. Alcoholic beverages and glass objects are not permitted
7. Bicycles may not be ridden within the Recreation Center. Bicycles must be left outside the fenced areas, at the owner's risk, in designated bike racks.
8. Roller skates, in-line skates, skateboards or similar equipment are not permitted in the pool or spa area. Wheelchairs and baby strollers are permitted.
9. Pets are not permitted.
10. Loud music is not permitted.
11. Professionally taught instruction is prohibited.
12. Pool life saving equipment is for emergency use only, and must be left installed at all times.
13. Anyone using the recreational facilities does so at their own risk, responsibility and liability
14. It is the responsibility of each resident to ensure that children under the age of 14 are under the direct supervision at all times of a designated, responsible adult (18 years or older) while in the pool area. (CALIF. ADMIN. CODE TITLE 22 SEC. 65539(c)).
15. Children under 14 years old must be under direct adult supervision (18 years or older) while in the spa. (CALIF. ADMIN. CODE 1111~E 24 2902S.)
16. General rules of good conduct should be observed at all times. This includes no running, pushing or boisterous behavior. Voices should be kept at a volume suitable for private conversation. Radios or other stereo equipment should be used only with earplugs when others are present at the pool. This is especially important during early morning and late evening hours. As always, parents are responsible for supervising their children's activities.
17. No diving allowed.
18. Absolutely no foreign substances such as bubble bath, soap, drinks, etc. may be added to the pool or spa. Persons observed doing so will be assessed the cost of draining, cleaning, refilling and other costs incurred due to pool or spa damage.
19. Throwing non-floating items such as rocks, marbles, and the like, into the pool is prohibited
20. Usual and customary swimming attire is required. Nude or partial nude sunbathing or swimming is not permitted. Cutoffs or other street attire do not meet this requirement.
21. Infants and toddlers must wear diapers with waterproof pants with elastic at the waist and legs at all times (no cloth diapers).
22. Hairpins, hair clips or other similar objects should not be worn in the pool or spa since their loss poses a substantial risk of damage to the pool or spa equipment.
23. No bogey boards, rafts, or large inner tubes are allowed in the pool area. This does not apply to legitimate life saving devices such as baby floats or life preservers that remain fastened to the body. Noodles and floaties are allowed for flotation purposes only.
24. Pool furniture is to be used on the decks around the pool and spa areas only. Do not remove them from the pool area, and make an attempt to clean them off (if necessary) before leaving.
25. Absolutely no smoking, eating or drinking is allowed in the pool or spa.
26. No barbecues allowed in the pool or spa enclosure.
